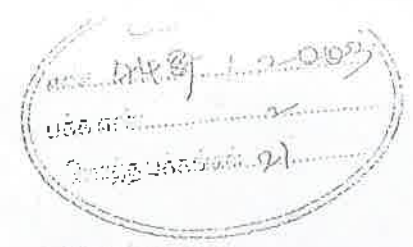

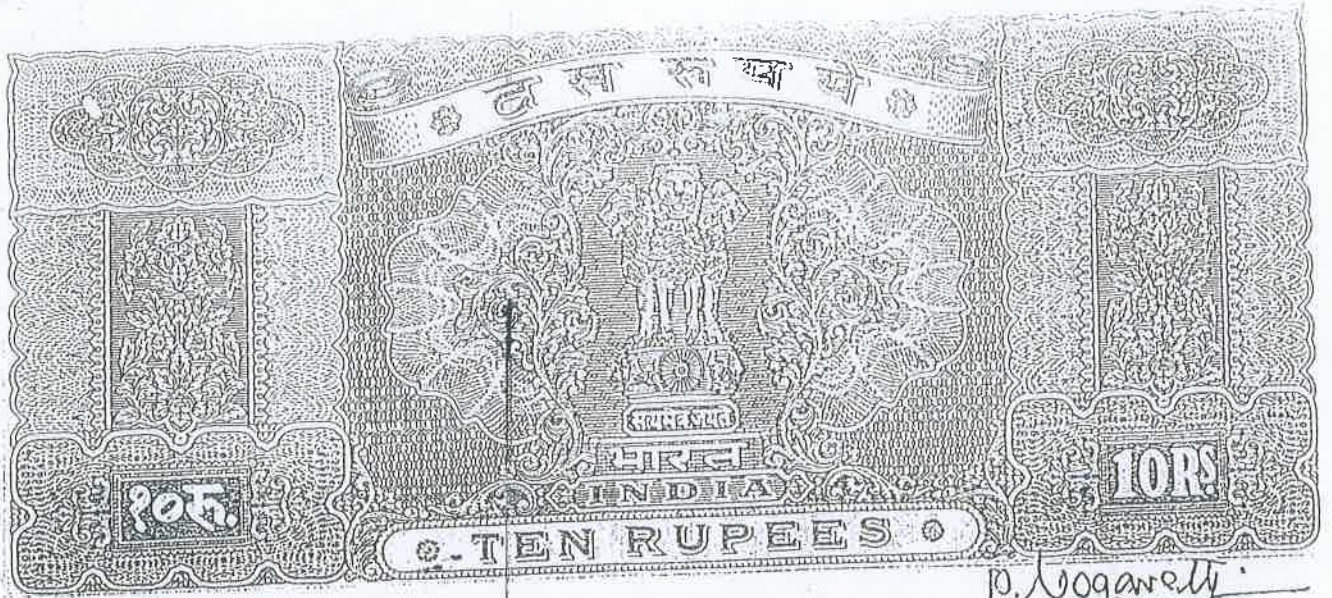

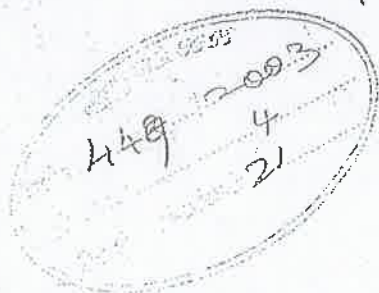

- To develop a healthy as well as critical attitude towards the development of mental, physical and moral uplift of the students and those connected with the institutions so as to make them good citizens.

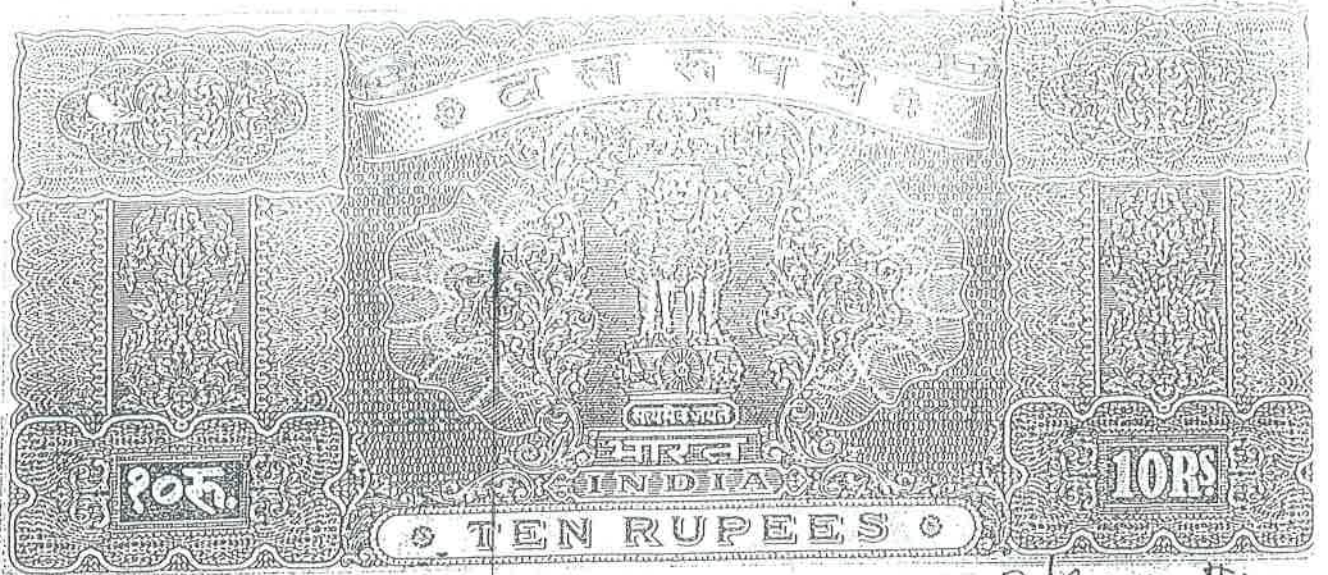

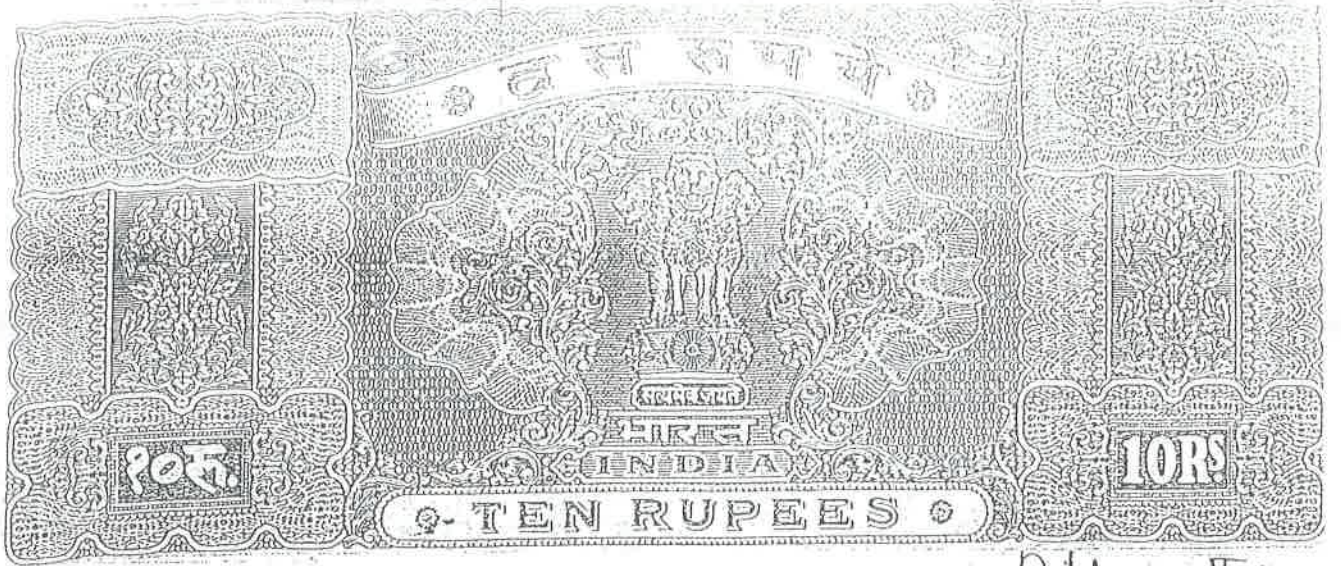
- b) Any meeting of the board of Trustees shall be presided over by the Chairman.
